# MINUTES OF THE MONTHLY MEETING OF SANDY LANE PARISH COUNCIL HELD ON MONDAY 17<sup>TH</sup> FEBRUARY 2020 IN BETHEL BAPTIST CHURCH, SANDY LANE, COMMENCING AT 7.30 PM

#### 16/20 Apologies

Apologies noted and the reasons for absence approved for Cllrs Tim Grace and Sughra Nazir; apologies also noted from Ward Cllrs Sue Duffy and Richard Dunbar and representatives from the local police.

#### 17/20 Declarations of interest

None received.

## 18/20 Minutes of previous meeting

Minutes of the previous meeting held on 13<sup>th</sup> January 2020 were confirmed as a true record and signed by the Chair.

#### 19/20 Public forum

## 1. Traffic issues:

A member of the public expressed concern regarding the traffic at the school, reporting a recent incident involving a school staff member and volunteer and a parent, who was challenged for illegal parking. Mr Gondal reported that he has been working closely with the school and the Ward Clirs regarding traffic in the village, as well as anti-social behaviour, with a view to looking for positive solutions. The Parish Council agreed to send some flowers to the two individuals on behalf of the village.

A member of the public reported that the lights at the school are now flashing, however they are facing the wrong way: Mr Gondal to report this.

A member of the public reported that there is still a missing traffic light from the crossroads in the village: Mr Gondal to investigate this.

A member of the public requested that there needs to be a 'single file' sign at the traffic lights outside the church on Cottingley Road as many drivers assume it is not and the road is insufficiently wide for two cars: Mr Gondal to investigate this.

A member of the public expressed concern regarding the double yellow lines outside J+H Stores at the top of Prune Park Lane, as it is causing cars to park blocking driveways, therefore either the lines need removing or more Wardens need to be patrolling the area: Mr Gondal to report this.

## 20/20 Representation from local police

Item deterred to the next meeting when the representative from the police may be in attendance.

## 21/20 Sandy Lane Cricket Club and Junior Foot Club

Item deterred to the next meeting when the representative from the Cricket Club may be in attendance.

### 22/20 Representation from Ward Officer

Mr Gondal confirmed that he can provide a link to Bradford Council when the Ward Cllrs are not in attendance: agreed to amend the agenda item to include representation from Ward Officer/Ward Cllrs.

Mr Gondal highlighted the 'Keep Britain Tidy' scheme in March and April: to send further information to the Clerk for dissemination to all and to include on next agenda. It was reported that there is an unsightly piece of litter filled land at the end of Rosedale Avenue, which is attracting vermin and therefore a health

concern: Mr Gondal agreed to write to the landowners regarding this concern.

Regarding the summer event, Mr Gondal agreed to liaise with the Parks Dept to request for the grass to be cut and the litter bins emptied prior to the event and for litter bags and pickers to be supplied, and also to liaise with the Youth Service regarding attendance.

Mr Gondal also agreed to liaise with the appropriate representatives at Bradford Council regarding the cutting down of the trees at the bottom of Haworth Road, opposite number 442, and also the removal of a dangerous tree opposite 80 Dale Croft Rise.

Mr Gondal also agreed to report to Bradford Council the dangerous steps leading down to Stony Lane from Grasleigh Way.

Ward Cllr Mullaney to investigate potential tradesperson for this work; Clerk to verify that the Parks Dept are still able to cover 50% of the cost of the new railings.

4. Neighbourhood Development Plan:

Agreed that a Parish Council stall be held at the summer event, to determine whether there would be public support for a Neighbourhood Development Plan.

- b) The Parish Council have **NO OBJECTION** to application 20/00523/HOU two storey side extension and part single storey rear extension at 33 Syringa Avenue, Sandy Lane. Clerk to contact the Planning Department accordingly.
